

Agreement to Use Facilities and Services Provided and Waiver of Liability

Sunrise Play Park, the building and the grounds it is contained on are owned and operated by The Corporation of the Anglican Parish of the Nerepis and Saint John, hereinafter referred to as SPP. This waiver is effective for the entire grounds and all buildings contained therein.

1. Explanation of waiver. Agreement of legal authority to sign on behalf of self and children.

- This waiver is required for any persons who are entering SPP, either the play space or any other part of the grounds, either to play, participate in a party, or join any group meeting at or any activity taking place at SPP. I am the parent, caregiver of or have been authorized by the parent or caregiver of the child/children with me to represent them and myself in signing this waiver.

2. Understanding risks. Play at your own risk.

- **I understand that inherent risk of injury or illness, though minimal, does exist.** SPP and its staff work diligently to provide a safe environment for all; however, certain risks, whether inherent in the facility itself or caused by myself, the child/children with me, or others using the facilities, are unavoidable. I, for myself and the child/children with me, freely assume full responsibility for my and the child's/children's participation at SPP and freely assume all risks, both known and unknown. I and the child/children with me agree to comply with all safety rules and to obey the directions and requests of SPP staff.
- **Such risks and hazards include but are not limited to:**
 - Falls on or from the equipment
 - Slipping on ice in the parking lot
 - Tripping
 - Collisions with the equipment or with other participants
 - Damage to personal property
 - Personal injury or death.

3. Statement of health and physical condition

- The child/children and I have no illness or injury that may affect the safe enjoyment of SPP by us or other guests.
- The child/children and I are in good physical condition and physically able to play in the SPP premises. The child/children is/are old enough to participate.
- **I have ensured the children are aware of the safety rules.** I have read and understand the SPP safety rules ("Rules"). I and the child/children agree to use the SPP facilities only in accordance with the Rules.

4. Waiving rights and responsibilities.

- I, for myself, the child/children and on behalf of my and their heirs, assigns, personal representatives and next of kin, hereby waive, release and discharge SPP and its directors, officers, agents, employees, owners and representatives (collectively 'SPP') with respect to any and all losses, damages, injuries, expenses and claims, including without limitation suffered or incurred as a result of the child/children using SPP or being on the property, due to any cause whatsoever, for personal injury, death or loss or damage to person or property, even if arising from the negligence of SPP or otherwise and hereby agree to indemnify and hold harmless

SPP from and against any liability, losses, claims and damages resulting from my and/or the child/children using SPP.

- Interpretation and Severability . I agree that this Agreement is intended to be interpreted as broadly and inclusively as permitted by law. Should any provision of this Agreement be determined to be unenforceable, all remaining terms and clauses shall remain in force and shall be fully severable.
- Subsequent Visits. I agree that this Agreement shall apply with equal force and effect to mine and the child/children's present and future visits to and use of SPP.

I HAVE CAREFULLY READ THIS AGREEMENT AND WAIVER OF LIABILITY AND FULLY UNDERSTAND ITS CONTENTS.

I FULLY UNDERSTAND THAT BY SIGNING BELOW, I AM GIVING UP SUBSTANTIAL RIGHTS FOR MYSELF AND THE CHILDREN AND DO SO VOLUNTARILY.

I AM AWARE THAT THIS IS A BINDING CONTRACT AND AM SIGNING IT WITHOUT INDUCEMENT, ASSURANCE OR GUARANTEE AND ENTIRELY OF MY OWN FREE WILL AND ACCORD. READ AND APPROVED BY SPP.
